Good afternoon Tammy,

My answer to the survey questions:

1. Will you oppose privatization of municipal services and infrastructure, including Public-Private-Partnerships aka P3s? Will you support bringing previously privatized services in-house?

Yes, I will oppose and will advocate against the privatization of our municipal services. I support public services being delivered by public employees.

2. Will you support your employees and your community by ensuring the municipality employs staff with living wages, full-time hours where desired, job security, and collective bargaining rights?

I wholly support municipality staff receiving living wages, full-time hours, job security and having collective bargaining rights.

3. Will you oppose attempts from the provincial government to legislate against municipal staff including cuts to the Local Authorities Pension Plan, or restrictions on their right to strike?

I would oppose any attempts from the provincial government to cut pensions or restrict employees' right to strike.

4. How do you propose your municipality deal with funding shortfalls, cuts, and downloading of responsibilities from federal and provincial governments? Do you favour spending cuts over tax increases?

I believe a balance needs to be struck to ensure service delivery in a fiscally responsible way. I would advocate for a reduction on the amount we spend on Consulting firms, and a freeze on Council salaries. I am also in favour of tax increases to meet population growth and inflation.

5. Do you support measures such as mask mandates, vaccine "passports", and vaccine mandates for staff to limit and reduce the spread of COVID-19 in your municipality?

I support any measure that protects the lives and safety of our employees and constituents. Mask mandates, proof of vaccination and vaccination mandates have

become necessary to combat this pandemic. We must follow the advice and guidance of our health experts.

6. Do you support measures to reduce municipal reliance on services fees and fares, such as eliminating transit fares?

I believe public transit needs to be affordable and accessible to improve ridership, and I support removing financial barriers to accomplish this goal.
