Candidate For Calgary City Councillor Ward 10

1. Privatization, including P3s

Based on the fact that many private corporations subsidized by the government are doing using Canadians' taxes to run their semi private business, most of them are doing a bad job. They are neglecting to do a good job.

I oppose privatization of public assets, and liabilities that belong to the public.

The leaders who govern the City of Calgary and leaders from the AB government, should be able to properly manage the City assets and liabilities, for the community's well being.

The City leaders before making any arbitrary decision, should communicate first with people from each community's assembly, to arrive to make decisions.

To find the ways to improve the standard of life and well being of all kinds of workers in Calgary, and to improve the services given to communities.

The City with communities working together to make decisions, to protect public belongings, like Health Care programs, Hospitals buildings, public land, parks, roads, golf courses, that belong to communities, built by Christian pioneers for people's well being to enjoy it. The public services should be delivered by The City governors. and they should be able to manage the programs properly, for Calgarians well being.

and to clean the snow from streets in residential areas to avoid incidents.

2. Municipalities and employers:

People who work for the City in any level or position getting full time job, enjoying good salary and all kind of benefits, that the average workers we do not have those privileges, governors should consider to look into economical issues that are affecting to working class people, working poor class, and seasonal workers, to increase their salary so they can have a decent salary to pay mortgage and living expenses, after paying utilities bills, to have money to buy food to put in our table, to keep good health for every workers well being. While in unemployment Insurance a lot of workers are looking for a job, to be hired, and it is difficult for them to get a job, most of them are surviving in food banks and some became homeless in their own country Canada where they were born. Many workers are low income, having financial difficulties to pay rent. In each community there are social economic issues to look at, to find good solutions for everybody's well being.

3. AB governors, leaders who are governing Alberta in any kind of position, they do not have to cross the line, they should learn to respect people's rights to have a decent salary, decent pension plan for everybody's well being.

We are living in a free country in Canada. According to Canada's constitution people have freedom of expression, comments and opinions.

If governors who are governing wrongfully, taking advantage of their position to commit abusive power, do not listen to people's concern and complaint, that situation pushes workers to strike if necessary.

Funding:

Many corporations become rich and wealthy using subsidized programs sponsored by the government, who are using taxes to feed them to become wealthy.

4. There are many ways to solve financial situations that are affecting Canadians workers and to many people in Calgary Canada.

It is not necessary to increase taxes, to supply people's needs, to supply workers' needs.

Solution to the problem:

A). To stop privatizing public assets and liabilities that belong to the City to the public.

B). In Alberta Canadians born in Canada under 65 years all they do not have free medication, no free glasses and lack of dental programs, privileges that others have in the first day they arrive into Canada, privileged giving to them social subsidized programs, welfare, monthly financial help, free medication, affordable housing given to them, privileges DENIED to CANADIANS WHO ARE HOMELESS.

Some homeless people are living in a temporary lodge for 3 months, after the temporary lodge, welfare cuts the services to them, welfare unstable services affect homeless people, morally, mentally and physically.

Human rights services and equal opportunities should be applied in Calgary, for everybody's well being. inclusion in those programs for homeless people too.
