1.

The Ministry sets curriculum and that is a fact. We elect them to represent us and it is clear to me this new curriculum does not reflect the needs of 21st century students nor the will of the people. A one-size-fits-all cookie-cutter ideology of education does not serve us well. It never did. This is the moment in time to get history on point; to make sure we leave behind the monocultural mistakes of the past and create accurate curriculum that empowers historical and cultural reconciliation in our multicultural society.

That being said, I firmly believe that the US and THEM camps are growing wider every day. As a trustee I want to find, build or resurrect the needed bridges between concerned public voices and the Ministry of Education.
