After signing a tentative agreement with the employer in early September, the parties met again and resolved the few outstanding non-monetary issues. The mediator will write supporting recommendations, so we now have a tentative agreement for Nursing Care members to vote on!

Your negotiating team is holding virtual information meetings on **November 1**, to present the details of the tentative agreement. To accommodate varying shift schedules, two meeting times have been arranged. Members can choose to attend the information session from **1:00PM to 2:30PM or from 5:00PM to 6:30PM.**

Your negotiating team strongly encourages all members to attend one of the information meetings and to exercise your right to vote!
